- Awareness of British Values and Citizenship
- Prevent Duty Awareness
- Understanding Safeguarding in a Learning Environment

They collectively underpin government policy and support educational institutions and other public bodies in fulfilling their responsibilities in these areas. Learners undertaking any of the qualifications will have an increased awareness of these topics and help providers meet and evidence their obligations towards the spiritual, moral, social and cultural development of their learners.

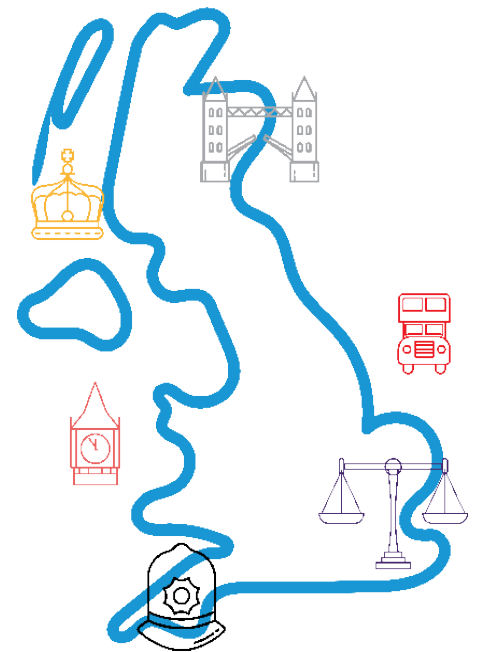
OCNLR LEVEL 1 AWARD IN AWARENESS OF BRITISH VALUES AND CITIZENSHIP

(1 CREDIT/8 GLH)

The **OCNLR Level 1 Award in Awareness of British Values and Citizenship** has been developed to help learners find their way around this complex and sometimes challenging subject and to help fulfil the responsibilities of training providers in this area. It can also form part of the safeguarding agenda and includes elements from the citizenship curriculum.

OCNLR ENTRY LEVEL 3, LEVEL 1 AND LEVEL 3 AWARDS IN PREVENT DUTY AWARENESS

The purpose of the **OCNLR Entry Level (Entry 3) Award in Prevent Duty Awareness (1 Credit/8 GLH)** is to raise awareness of the Prevent agenda and the duties required under it amongst learners in schools and colleges. The **OCNLR Level 1 Award in Prevent Duty Awareness (1 Credit/6 GLH)** is similar to the Entry level Award but has different assessment requirements and is pitched at a more demanding level. This qualification may also provide awareness—or continuing professional development—for staff and organisations who may be affected by the Prevent agenda but do not require the **OCNLR Level 3 Award in Prevent Duty Awareness (2 Credits/8 GLH)**. This higher level qualification is primarily aimed at managers, practitioners and support staff who have a duty under the Prevent agenda.

OCNLR LEVEL 1 AWARD IN UNDERSTANDING SAFEGUARDING IN A LEARNING ENVIRONMENT

(1 CREDIT/8 GLH)

The **OCNLR Level 1 Award in Understanding Safeguarding in a Learning Environment** has been developed to enable learners to be taught about safeguarding within the context of their own learning environment.

It also helps schools and colleges identify and respond to concerns about the safeguarding and protection of children, young people and vulnerable adults.

OCNLR LEVEL 1 AWARD IN UNDERSTANDING SAFEGUARDING IN A WORKING ENVIRONMENT

(1 CREDIT/8 GLH)

The **OCNLR Level 1 Award in Understanding Safeguarding in a Working Environment** aims to help learners understand policies and procedures for safeguarding in preparation for working on an industry placement.

This qualification also covers the meaning of the Prevent duty and the key people involved with the Prevent duty in a working environment.

HOW THE QUALIFICATIONS ARE ASSESSED



Assessments are internally set, marked and moderated by the centre. The resulting portfolios are then externally moderated by OCN London. We encourage flexibility and variety in approaches to assessment using the guide given on each unit in the respective qualifications.

Access to assessment materials set and centre-marked by OCN London are available for the Level 1 Award in Prevent Duty Awareness upon request and at no extra cost.
